



Wi-Fi Countdown Timer Switch

Hold the button (5 Min button) until the LED indicator flashing quickly to turn on/off the LED indicator.

Hold the button (30 Min button) until the LED indicator flashing quickly, Wi-Fi network configuration is displayed.

Hold the button (2 Hour button) until all indicators light up, keep press the button to adjust a lower brightness then release the button.
